

IMAGE USE CONSENT APPENDIX

SCOPE OF CONSENT

You (and, if you are under 18 years of age, you and your parent or legal guardian) acknowledge and agree:

- Cricket Organisations may, from time to time, record or take photographs at training, matches and other cricket events;
- images and recordings of training, matches and other cricket events may be used by Cricket Organisations on websites, social media pages, advertising materials and in other publications;
- recording equipment at matches, training and other cricket events may record your image, voice and other identifying features.

By providing this consent and attending or participating in any match, you (and, if you are under 18 years of age, you and your parent or legal guardian) consent to photographs and recordings of matches and the use of this information publicly, as described below.

This appendix does not include consent for livestreaming, including but not limited to Frogbox. Consent to livestreaming is managed through a Cricket Participant's Play HQ Account and can be updated at any time. Should you change your consent preference, please inform your Cricket Organisation's Secretary.

USE OF IMAGES AND RECORDINGS

Images and recordings and footage may be used by Your Cricket Organisation and/or any other Cricket Organisation, or their representatives or partners, for purposes which may include:

- training and education purposes such as skill correction, analysis or for training tools;

- promotional or marketing purposes, for example, images, recordings and livestream footage may be featured on cricket club or governing body websites, social media pages or in other publications;
- for commercial purposes such as commercialisation of highlights packages;
- for investigatory, complaint management, or disciplinary purposes, for example, images and recordings may be used as evidence in any investigation, hearing or disciplinary process brought in under relevant competition rules.

CONSENT & RELEASE

I give permission for my (and/or the under 18 participant's) image or physical likeness, voice, name and/or biographical information to be featured in images and recordings and be used for the purposes set out in this form.

I relinquish (and/or relinquish on behalf of the under 18 participant) any rights, title or interest that I (and/or the under 18 participant) may have in the images and recordings and/or sound, and agree that I (and/or the under 18 participant) have no rights to fees, remuneration or royalty in exchange for my (or their) appearance in the images and recordings.

I agree (and/or agree on behalf of the under 18 participant) that my cricket club and/or Cricket Organisation will be the sole owners of all rights, title and interest in the images and recordings, and have unrestricted and perpetual rights to use the images and recordings for the purposes set out above.

I waive, release and forever discharge (and/or waive, release and forever discharge on behalf of the under 18 participant) all Cricket Organisations from all claims, actions and liability relating to the use of my (or the under 18 participant's) image, physical likeness, voice, name and/or biographical information name or image.

WITHDRAWAL OF CONSENT

You may withdraw your permission for you (and/or the under 18 participant to be featured in images and recordings for the purposes set out in this form at any time. You must provide written notice of such withdrawal to your Cricket Organisation's Secretary and to privacy@cricketnsw.com.au.
